JX Nippon Oil & Gas Exploration Corporation discovered gas in Australia and oil in Papua New Guinea

JX Nippon Oil & Gas Exploration Corporation ("NOEX")(Makoto Koseki, President and CEO) have made a gas discovery in Australia WA-290-P and oil discovery in Papua New Guinea PPL-219. The joint venture plans to implement further evaluation programs to commercialize both projects.

1. Natural Gas Discovery in WA-290-P, North West Shelf, West Australia.

Nippon Oil Exploration (Dampier) Pty Ltd, 100% subsidiary of NOEX, observed approximately 125m of net gas pay in three Triassic Mungaroo sands with excellent reservoir characteristics through drilling of the Zola-1 exploration well in WA-290-P (located in 97 km north-northwest of Onslow, Western Australia with a water depth at 280 meters). NOEX will be working with partners to appraise this discovery and to commence discussions on development options for this resource.

2. Oil Discovery in PPL-219, Papua New Guinea

Merlin Petroleum Company, 36.4% subsidiary of NOEX, and Nippon Oil Exploration (Niugini) Pty Ltd, 25% subsidiary of NOEX, observed oil in three separate sandstone layers of Lower Cretaceous Toro formation through drilling of Mananda-5 exploration well in PPL-219 (located in PNG highlands area). The flow test implemented after the discovery showed good result. NOEX will be working with partners to appraise this discovery and to commence discussions on development options for this resource.

NOEX is actively proceeding with the upstream business in Oceania region such as Mutineer-Exeter oil production in North West Shelf, Australia, oil production and participating LNG project in Papua New Guinea. NOEX will continue to do oil/gas exploration and production in this region for the establishment of integrated business model of JX group and energy security for Japan.
