ENEOS Xplora Invests in "Green" Helium Business

ENEOS Xplora Inc. (President and CEO: Toshiya Nakahara, "ENEOS Xplora") is pleased to announce its investment* in Helium Evolution Incorporated ("HEVI"), a Canadian-based helium exploration company focused on developing assets in southern Saskatchewan, through its affiliated company ENEOS Xplora USA Limited (President: Takeo Tanei), amounted approximately Canadian dollar 2.7 million.

Helium is a naturally occurring element that cannot be synthesized and is usually obtained as a byproduct of natural gas processing with a greenhouse gas emission. Since nitrogen is not a greenhouse gas, the supply of green helium will encourage the decarbonization of the helium industry.

The world demand for Helium has been solid over the last decade and is expected to grow in the long term, as it is a key component used in a wide range of applications, such as semi-conductor manufacturing, MRI machines, and glass fibers production. ENEOS Xplora believes that this investment will mark the first step in this promising industry.

ENEOS Xplora is committed to expanding its role beyond the traditional oil and gas exploration and production, and to contributing to the sustainable future.
