2. Beliefs and expectations for each project

In Vietnam, we have reached a historic milestone of 250 million barrels of cumulative oil production last year.

In Malaysia, last year we carried out the additional development of the Helang gas field. In addition, we have newly acquired interests in the 'BIGST Project,' a large-scale project that includes the development of high CO₂ gas fields utilizing CCS. This year, in cooperation with Petronas, we will further evolve and materialize the "BIGST Project". And we will focus on realization of maximizing the value of the SK10 field.

Our LNG projects in Indonesia and Papua New Guinea are major contributors to our cash flow. Last year, we sanctioned the FID (Final Investment Decision) for the 'UCC Project', an expansion project that also includes CCUS, at the Tangguh LNG Project in Indonesia. In Papua New Guinea, there was also the exciting news of the start of production at the new gas field of the PNG LNG project. We will continue to fully cooperate with the partners to further expand our business in both countries.

Domestically, the Nakajo Office, which changed its name to coincide with the company name, will increase a production of natural gas dissolved in water and iodine through phased additional development. Aiming to build a sustainable income-generating business structure, this year will be for laying the foundation for the future.

The Petra Nova CCUS project in the U.S. is our flagship project for the environment-friendly business with the capacity of 1 million tons of CO₂ storage annually. We aim to develop environment-friendly business centered on CCUS by leveraging experiences and knowledges gained from the Petra Nova project.

The major prerequisites for achieving what I have described are "compliance" and "HSE". Let us continue to focus on these efforts.
